

## REQUEST FOR RESIDENCY POINTS

THE ATTACHED FORM IS TO BE COMPLETED BY FIREFIGHTER APPLICANTS WHO ARE CITY OF BRISTOL RESIDENTS AS OF MAY 1, 2021, WHICH IS THE CLOSING DATE FOR APPLICATIONS; AND WHO WISH TO RECEIVE FIVE POINTS ADDED TO A FINAL PASSING SCORE (maximum 100 points). In order to be eligible for residency points, irrefutable evidence substantiating that you are DOMICILED in the City of Bristol ON MAY 1, 2021, and have maintained such residency throughout the testing process is required.

For purposes of this request, "DOMICILED" is defined to be "that place where an individual has his/her true, fixed, and permanent home and to which whenever he/she is absent, he/she has the intention of returning".

The attached form must be uploaded with your online application; OR mailed to City of Bristol, Human Resources, 111 North Main Street, Bristol, CT 06010, postmarked by May 1, 2021, OR brought to Human Resources by 5:00 p.m. on May 1, 2021. Copies of documents to substantiate legal domicile must accompany the form, including a copy of a valid driver's license. Other acceptable documents include but are not limited to: copy of utility bill, motor vehicle registration, etc. All documents are subject to verification by the Director of Human Resources.

IMPORTANT NOTICE: THE APPLICANT BEARS THE BURDEN TO ESTABLISH PROOF OF LEGAL DOMICILE. ANY FALSE OR MISLEADING INFORMATION OR DOCUMENTS MAY RESULT IN IMMEDIATE DISQUALIFICATION FROM THE CITY OF BRISTOL FIREFIGHTER TESTING PROCESS, REMOVAL FROM SUCH ELIGIBILITY LIST OR DISMISSAL FROM EMPLOYMENT AS APPLICABLE.
